- 1. The name(s) of the author(s)
- 2. A concise and informative title
- 3. The affiliation(s) and address(es) of the author(s) with email address, mobile number.

Abstract (250 words) and full paper (3000 words) must be limited to 6-8 pages, A4 size paper, excluding the tables and references. Format conditions: APA citation / reference style, Times New Roman font, font size 12 for text, 13 for sub heading and 14 for main heading, line spacing 1.5. The author (s) should submit their Soft Copy of the paper in English, mailed in word file only to theresaconference@gmail.com.
