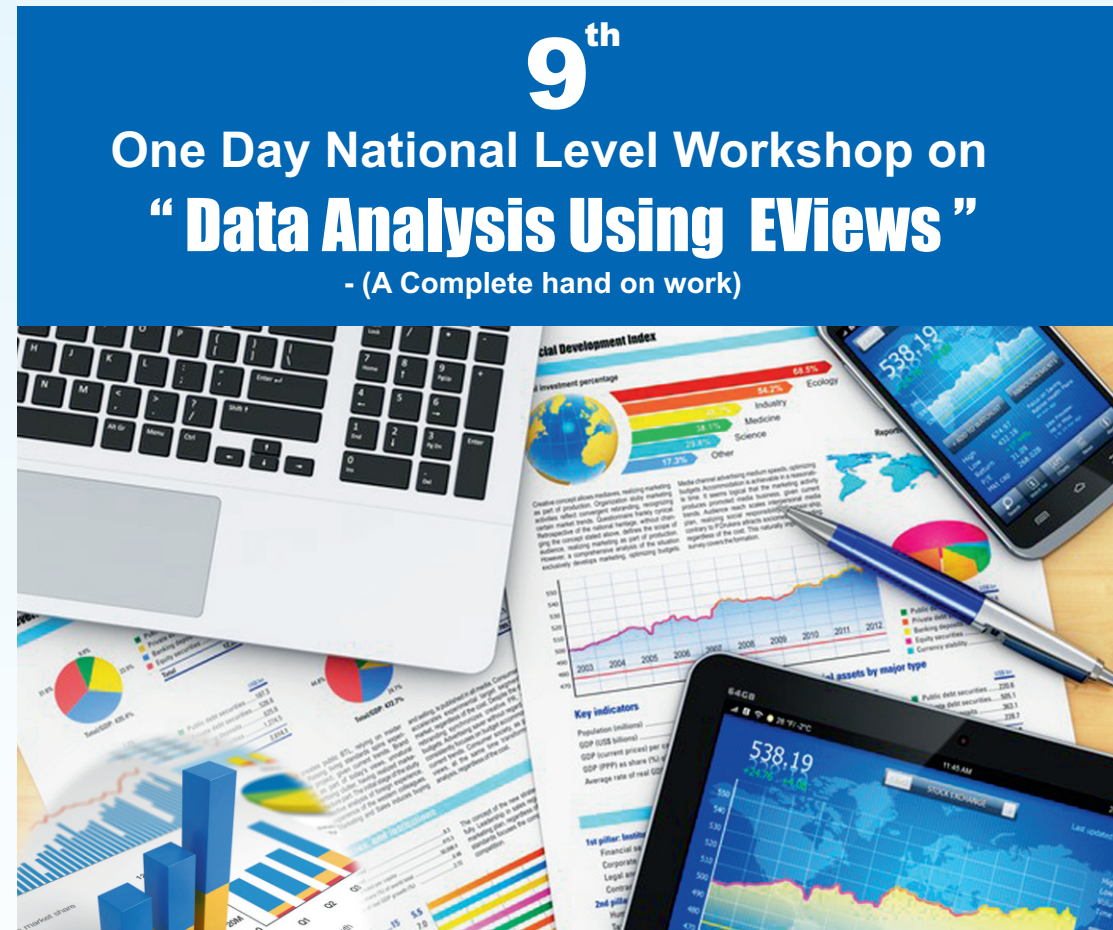

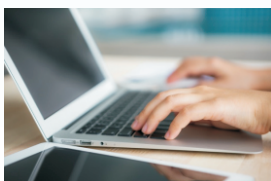
About the workshop
